6. Company Rights & Obligations

- Issue the membership card within 14 days upon receipt of payment.

- Reserve the right to modify benefits, fees, or terms with prior notice.

7. Fees & Validity

- Membership fee: ₹ 1500 per solar Plant up to 3 KVA , Rs 300 per KVA for additional Charges including GST.

- Renewal terms: Consumer may renew upon payment of applicable fees after validity period of membership card which will expire in five years
